

for the Federal Pavilion. On July 27, 1962 when President Kennedy signed the bill appropriating \$17,000,000 for the Pavilion, he stated "that the theme' Challenge to Greatness', proposed by a citizens' committee established by Secretary of Commerce Luther Hodges, will enable us to present to the world not a boastful picture of our unparalled progress, but a picture of democracy - its opportunities, its problems, its inspirations and its freedoms!

The Federal Pavilion will cover more than a city block and will seemingly "float" 18 feet above the ground on four supporting columns. Its two exhibit floors, of almost 150,000 square feet will handle 40,000 visitors daily. As high as an 8-story building, the building's exterior wall will be fabricated from thousands of vari-colored glass pieces that will reflect sunlight during the daylight hours and glow with interior light at night. The enclosed Garden Court will function as a central meeting place with access to all exhibits. It is exposed to the sky, yet protected on four sides by the inner walls of the Pavilion. It will provide an oasis of peace and quiet from the noise and bustle of the Fair.

Cinerama Camera Corporation will design and operate a combination film and threedimensional exhibit for the Pavilion.

This exhibit will depict the "Pioneer Spirit of America" past, present, and future and will be installed on the second floor. A specially designed vehicle will enable 3,000 visitors to view the exhibit each hour.

FEATURES

The Florida Pavilion, situated on Meadow Lake, will be a complex of buildings to show Florida's history, current and future potential for living, vacationing, industrial development and cultural pursuits. A one hundred-ten foot citrus tower, a spectacular porpoise show, two model Florida homes and a large exhibit hall will be featured.

FEATURES (cont'd)

The entire area will be landscaped with semi-tropical vegetation, pools and fountains simulating Florida living.

The 110 foot citrus Tower topped with a giant orange which lights up at night, will be the landmark of the Florida exhibit. Near the top of the tower, a sign, 24 feet long and 3 feet wide, will spell out Florida on each side. The circular building, 50 feet in diameter at the base of the tower will be occupied by the Minute Maid Company.

A beautiful 250 foot long bridge called "Bridge to the Keys" will lead to the two model retirement homes. These homes will be furnished and set in a Florida landscape of grass, shrubs, palm and citrus trees.

They are two bedroom models, priced at about \$12,000.

Florida will also present the first live porpoise show ever seen at any international exposition. Ten shows will be given daily in a 1,600 seat theatre.

Wellman-Lord Engineering, Inc. will have several scale models of phosphate chemical plants to demonstrate the chemical process and show have materials are produced and the finished product obtained.

Patricia Murphy will have a gift shop in the exhibit.



FEATURES

The Hawaiian Exhibit with a hundred feet of water frontage, has been designed to display the utmost of the beauties of this Pacific Paradise. The theme of the exhibit is "Aloha".

Akua Tower: At the northwest corner of the site the Akua or Tiki Tower is 80 feet high and will have a traditional Hawaiian design facing in two directions. Fifty-five feet above the base and surrounding the tower is a ring of six flaming torches. Thirty feet from the base is a ring of ceremonial Kahili standards illuminated at night in a pattern of tiny spots of light.

Aloha Theme Pavilion: The columns of the Aloha Theme Pavilion will rise from a reflecting pool crossed by a bridge at its entrance. The entrance will have an impressive 20 foot waterfall and a Ku figure from Polynesian mythology. This building will contain exhibits tracing the history of Hawaii from the arrival of the Polynesian people

a thousand years ago, through the arrival of British Captain James Cook in 1778, the coming of the missionaries, the establishment of the Hawaiian monarchy in 1810 and its history through 1893. The historical development of Hawaiian agriculture will also be traced in this building and the influx of Chinese, Japanese, Filipinos, Portuguese and Americans to the islands will be portrayed. The present-day sociological harmony of Hawaii will be graphically portrayed throughout as part of the overall "Spirit of Aloha" which will govern the exhibit. Hawaiians of various national and ethnic derivations will be depicted in government, industry, agriculture, education, civic associations and all other walks of life. Other exhibits will include the story of government and statehood, Hawaii's role as a bastion of U.S. defense in the Pacific, the cultural life of Hawaii and the current development of new "think industries" in the state.

Tourism and Industrial Exhibits: The visitor will approach this area by means of an elevated walkway. Here they will find color visuals showing the wonders of Hawaii and exhibits portraying tourism and travel with a Hawaii Visitors' Bureau information booth. Various Hawaiian industries and businesses will contribute to this part to communicate the healthy growth of business and industry in Hawaii and the opportunities there for future industrial and commercial development.

Hawaiian Restaurant: The Restaurant of the Five Volcanoes and the Lava Pit Bar will occupy approximately 10,000 square feet of space and will serve Hawaiian specialties in an authentic style and setting. It will have a seating capacity of 500. There will also be a Sandwich Isle Bar, a snack bar for Hawaiian specialties such as fresh pineapple sticks and juice, Kona coffee, teriaki steaks, fresh papaya and papaya juice, passion fruit and macadamia nuts. In addition, the famous pageantry feast of Hawaii, the Luau, will be featured on Tuesdays, Wednesdays, Thursdays and Sundays. The colorful and unique Luau will include the festive dinner of imported fruits and foods and all the rum punch one can drink, together with the re-enactment of ancient Hawaiian rituals and Polynesian entertainment.

<u>Hawaiian Shops:</u> The Hawaiian Exhibit will also have a series of five shops accessible from the main roadway and also from within the exhibit area. Hawaiian merchandise such as arts and crafts, fabrics and fashions, foods and flowers and a decorator shop will be featured in this area.

Ancient Hawaiian Village: An ancient Hawaiian Village, similiar to the popular Ulu Mau Village in Honolulu will be constructed directly behind the Hawaiin shops and fronting on Meadow Lake. Lei, tapa, hat, quilt, feather and wood crafts will be demonstrated in this village as will the making of poi. There will be a staff of 14 men in the village and six canoe operators.

Alohatheatre: Performances of Hawaiian music and dance will take place at intervals during the day and evening in the Alohatheatre adjacent to the Ulu Mau Village and the industrial exhibits. The theatre will be situated on a man made peninsula facing the water and will be reached by means of walkways over a canal. The estimated seating capacity will be from 800 to 1,000 seats; while the stage on a man made island off shore, will afford excellent sight-lines for all seats in the Alohatheatre. This stage will also lend itself to fashion shows and other special events.

The Hawaiian exhibit will be generously landscaped with plants and flowers indigenous to Hawaii. A man-made, 20 foot waterfall at the entrance to the Aloha Theme Building will supply a small river which will weave its way through the grounds to Meadow Lake. Torches will be used liberally outdoors throughout the grounds to lend further genuine atmosphere to the exhibit.



The glamorous movie industry will be shown to Fair visitors at the Hollywood USA Pavilion. The visitor will enter the exhibit through a reproduction of the façade of Graumann's Chinese Theatre in Hollywood. The sidewalk will have hand and foot prints of the movie stars.

Inside, the visitor will view many of the sets used in recent films including "My Fair Lady", "Cleopatra", "West Side Story", "The Greatest Story Ever Told", etc. The many facets of moviemaking will be shown, such as wardrobe, make-up, lighting and film techniques. In the center there will be a museum of many of the mementos of the movie industry.

Live filming will take place in a small amphitheatre in the Pavilion. Hollywood personalities will make personal appearances in the exhibit.



Exterior: Illinois brick, low profile, and smooth, un-interrupted continuity of lines make the Illinois building a reflection of the Prairie State and the simplicity of Mr. Lincoln. The words of Lincoln in raised letters on the brick walls appear to support the building. The exhibit will explain why Lincoln continues to grow in Illinois political philosophy, cultural inheritance, social and moral consciousness, and economic development. The exhibit will feature the present day virtues of the state in industry, education and recreation.

Entrance Courtyard: The entrance courtyard which leads the way into the Pavilion will contain a monumental photo portrait of Lincoln, a new equestrian statue of the

young Illinois laywer by Anna Hyatt Huntington and a relief map of the state watched over by the famous Borglum "shiny nose" head of Lincoln.

Lincoln Exhibit Hall: The Lincoln Exhibit Hall features a giant panorama projection story of Lincoln, displays of Lincoln artifacts, the complete Lincoln photo collection, and will have regularly scheduled Lincoln exhibits from all over the world. On the east side of the hall the visitor will stop at the Gettysburg Address Alcove which will contain the Illinois owned original manuscript of the Address, equipped with multilanguage listening devices for the international audience.

Lincoln Theatre: "Great Moments with Mr. Lincoln", a 10 minute production which dramatizes the personality and philosophy of the Prairie President will be presented by Walt Disney's WED Enterprises. This unique dramatization will use newly developed techniques of three dimensional animation, called, "Audio-Animatronics", in a lifelike figure of Abraham Lincoln to recreate the words and thoughts of Illinois' famous son

Illinois Exhibit Hall: The Illinois Exhibit Hall will have examples of Illinois leadership in the arts, sciences, commerce, education and recreation.

<u>Historical Reference Library</u>: The Library will contain important books and documents which will be available for use in the reading room.

Special Exhibit Courtyard: Specific displays will treat elements of the Illinois story that best exemplify the state's advantages.

Tourism Center: The Tourism Center gives a sampling of the vacation pleasures in Illinois. A restoration of the Rutledge Tavern of New Salem will be in full operation as it is at the State Park, showing life during Lincoln's early Illinois years.

Special Exhibit Garden Area: The visitor can view the Special Exhibits Garden at his leisure or rest on one of the many benches placed in the area.



FEATURES

The Maryland Pavilion, a two story structure, is designed to provide a citadel for a display of the state's past, its present, and its future. The pavilion will incorporate a fisherman's wharf, a theatre, an exhibit area, a pool and a lounge and restaurant.

Fisherman's Wharf: To the right of the main entrance, a fisherman's wharf will be built largely of the same creosoted wood planking used in Maryland wharf construction. The wharf will offer a selection of crab cakes, fried chicken, ham, clams and beverages for snacks and light eating.

<u>Pool</u>: On the left of the entry way is a rectangular shaped pool. The pool is extended underneath the entry walk and wharf just far enough to give the illusion that water runs completely beneath. To symbolize the Chesapeake Bay, the pool is to be lined at the bottom with oyster shells and objects associated with Maryland waterways.

FEATURES (cont'd)

Theatre: In the theatre, every six minutes, there is to be a dramatic motion picture presentation of the Battle of Fort McHenry during the War of 1812. The movie will depict the writing of the words of the "Star Spangled Banner" by Francis Scott Key. Exits from the theatre take the audience into a brick concourse where the main exhibits are to be displayed.

Exhibit Areas: The introductory portion of the exhibit will include models of the "Ark" and "Dove", the two boats which carried 200 of Maryland's original settlers to its shores in 1634; the original document containing The Acts of Toleration; the original oil painting of General Washington resigning his commission of the State House, and a model of 189 year old state capital building.

Among the other sections are: Models and photographs of Chesapeake Bay and an aquaria depicting ships of the bay; engravings, photographs and original art work showing the facilities and advantages of the port, and a photographic trip through Maryland. The "Future" will be a selected panorama of what the city of Baltimore will look like when the rebuilding, rerouting and renaissance becomes a reality. Near the end of the exhibit area, there will be a concession stand where souvenirs of the state and mementos of its heritage will be sold.

Restaurant and Lounge: Housed in twin rectangular units, the lounge and dining areas are bridged by an open cross walk made of wood decking. A faceted awning between the units will diffuse the Maryland colors found in the canopy into the exhibit areas below. The restaurant will serve traditional Maryland dishes for which the state is noted. Menus, prepared to interest the uninitiated and delight the gourmand, are to feature seafood, poultry, ham, baked foods and desserts. An abstract painting of the Maryland flag executed in color plastic will be exhibited in the restaurant.

Suspended above the bar is to be a wood grid ceiling containing stained glass set into the apertures. An opaque paneled wall running the length of the room behind the bar and lounge will serve as a backdrop for a photographic exhibit.







In the regional portion of the exhibit the visitor will see original or replica landmarks affecting the development of the United States and the world.

Also included will be a relief model of New England. From this regional section the visitor will move out through beautiful landscapes that provide a flavor and fragrance of New England, to the village green and amphitheater where a variety of events are planned to include a town meeting and performances of the Boston Pops orchestra.

There will be separate exhibits for each state showing past achievements along with future aspirations. These exhibits will serve as information and tourist centers.

Planned also is a fish hatchery, a country store and a restaurant featuring foods for which New England has become famous.



FEATURES

The theme of the New Jersey Tercentenary Pavilion is "1664-1964 For Three Centuries People Purpose Progress". The World's Fair Tercentenary Pavilion will have continuous programs expounding this theme, coordinated with the state wide celebration which will be going on throughout the year.

Exterior: The Pavilion will consist of twenty-one small pavilions, each bearing the name of one of the counties of the State. The islands will be arranged about a central theatre and four interior gardens. Exhibit platforms spring from a continuous reflecting pool, which will serve to mirror the rhythms of the pavilions and the nocturnal brilliance of the Fair, as well as to create a barrier between the exterior promenades and the interior gardens. Roofs over each platform and over the theatre are suspended from sixteen tapered masts, or booms, grouped in clusters of four. At night the booms will be illuminated from below. The roofs will appear to float over the platforms, since the only connection between the two will be corner tie-down cables, one-half inch in diameter. At several points the visitor may descend from the exhibit platforms to the interior gardens to rest and relax at tables set among intimate gardens and shade trees within the complex.

<u>Interior</u>: Pageants and shows of all kinds will be presented in a performing arts area that will be created in four village squares in the center of the exhibit. Here visitors will become part of the State's 300th birthday celebration as they view local choral groups, bands, symphony orchestras and folk dances. New Jersey art and photography will be shown in outdoor displays in this area.

Each of the twenty-one islands is devoted to the "Faces of New Jersey" told in terms of its people. The first island will welcome visitors with a filmed message from Governor Hughes. Subsequent islands will show the faces including the following topics: Community, Transportation, Recreation, Tourism, History, Famous People, Industry, Chemical, Glass Making, Pharmaceutical, Food Processing, Oil Refining, Ship Building, Research, Education and finally the Potential of the State for the future. The final island will include an information center where maps, brochures and other publicity material will be available. An automatic answer machine will also be located in this area.



This spectacular show will have 12 individual stages and 6 revolving stages and the world's largest indoor ski run. A new version of a process, making simultaneous use of film and live actors will give an unique optical effect, and will serve to introduce the "Salute to Olympic Games".

One of the most elaborate productions planned for the show is the "Five Senses" number, an audience involvement during which the walls of the entire building change color and the air is permeated with a new summer fragrance called "Ice-Travagance".

HISTORY - The New York City Building designed by Aymar Embury was the home of the New York City exhibit during the 1939-1940 New York World's Fair. The two story rectangular structure was the largest permanent building erected for the 1939 Fair.

After World War II, the city offered the building as a temporary headquarters to the United Nations, then meeting and organizing in Hunter College. Within six months, the Assembly Hall, Office and Services were completed, to be used by the United Nations for the next five years.

The building also served as temporary administration headquarters for the 1964-1965 New York World's Fair for nine months during 1960.



Conceived as the "Country Fair of the Future", the New York State Exhibit will combine the activity and the excitement of the traditional local fair with a dramatic and unique architectural treatment that envisions a world of tomorrow. The exhibit

which will consist of three main structures, will include a "Tent of Tomorrow", three observation towers, and a theatre.

"Tent of Tomorrow": The "Tent of Tomorrow", the heart of the exhibit, is an elliptical building supported by 16 white concrete columns each 100 feet high. The pre-stressed cable suspension roof with translucent colored fiber glass panels will create a stained glass effect. The balcony will contain many industrial, government, artistic, agricultural and other exhibits including a glider, grape and apple orchards, and an aviary. The ground level will be the daily scene of various performing competitions as well as fashion shows and music by leading bands. The two fashion shows daily include all phases of the fashion industry such as jewelry, millinery, leather goods and hair pieces. There will also be a 700 seat restaurant operated by Schrafft's with automatic vending of all types of inexpensive meals, an exhibit of the Power Authority and a huge Terrazzo map of the state.

Observation Towers: Adjacent to the main structure will be three observation towers, rising 60 feet, 150 feet and 200 feet respectively. Each tower will be capped by an observation platform 64 feet in diameter. The two lower towers will be enclosed and will include eating facilities. The 200 foot tower will be the highest point in the World's Fair grounds. From this tower visitors will have a sweeping view of the Fair. All three towers will be accessible by elevators as well as stairs.

Theatre: The final component of the New York State installation will be a circular concrete theatre. The exterior of the theatre will be decorated with examples of "pop" art such as: a comic strip redhead laughing her head off; a Times Square-like billboard; an assemblage of parts from smashed automobiles; a green parachutist; the 13 most wanted men; fragments of blown-up photographs of the Sistine Chapel, a bald eagle, the Statue of Liberty and an astronaut capsule; and a group of formal black tuxedos made rock hard by treatment with polyester resins. The theatre will house several hundred people standing, who will view on the wide screen on the walls a panoramic motion picture of New York State as a place to live, work and play.





The West Virginia Pavilion will feature a model community of the future-an industrial park complex with provisions for business opportunity, gracious living and recreation side by side. Fair visitors will be introduced to West Virginia as a land of relaxation-an inviting oasis in which to live, work and play on a year round basis.

FEATURES (cont'd)

The pavilion will be a modified L-shaped design, with a pergola-like extension providing an additional wing of landscaped garden area. Sculptured pre-cast panels and artistically-treated glass provide an unusual pattern of exterior wall treatment. The outer structure also features majestic full color views of West Virginia's leading scenic resorts. Five translucent domes rise above the roof to give further definition to the structure. A free form reflective pool envelopes three sides of the building. The pool is bridged by a gently inclined ramp which affords access to the pavilion. Adjacent to the main entrance, a towering sculptural symbol rises to a height of 50 feet and represents the aspirations of the people of West Virginia, through the development of industry, education and natural resources.

The major areas of the pavilion will include:

An Information Rotunda: Themes depicting the State in all its major aspects, including the history, culture, government and educational institutions.

An Industrial Park: Dramatic exhibits sponsored by West Virginia's leading industrial firms.

West Virginia's Vacationland: The unspoiled natural preserve, with winter, spring, summer and fall activities for the entire family.

Coal Mine: The visitor will be taken on a trip through a West Virginia coal mine.

A Gift Shop: A full line of souvenirs, fashioned by West Virginia's craftsmen, including stemware shown by Mrs. John F. Kennedy during her televised tour of the White House.

An Astronomy Exhibit: (A Radio Astronomy Sky) Special effects will interpret the meaning of the radio-telescope, explain its ability to "see", relate its impact upon the world of science today, and explore the significance of this magic "window of the universe". The exhibit will incorporate a planetarium dome, dioramas, animation, motion pictures, sound, displays and other audio-visual techniques.
